The CSP-FLR does not perform the screenings but pays for them at more than 200 clinics and providers across the Finger Lakes Region. Services can include any of the services provided by a personal care aide, home health aide, or nurse. Recipients have flexibility and freedom in choosing their caregivers. The person acting on the consumer's behalf assumes full responsibility for hiring, training, supervising and –if necessary-terminating the employment of persons providing services.

Medicaid/New York State Department of Health <u>www.health.ny.gov/health_care/m</u> <u>edicaid/</u>	Medicaid is a government-sponsored insurance program for individuals of any age whose resources and income are insufficient to cover healthcare. Medicaid is a healthcare program that assists low- income families or individuals in paying for long-term medical and <u>custodial care</u> costs. Medicaid is a joint program, funded primarily by the federal government and run at the state level, where coverage may vary. Medicaid is available only to individuals and families who meet specified criteria. Recipients must be legal residents or citizens of the United States.
