



Enriched Housing Residences

Enriched Housing (EH) provides long-term residential care, often in apartment type setting, with a package of services for residents who are medically stable. Services may include: meals, housekeeping, homemaking/chores, shopping, transportation, social activities and some personal care assistance. There are two models of Enriched Housing Programs. The first operates in a freestanding building for all residents in the building. The New York State Department of Health licenses this type of program. The second model provides the package of services for a limited number of residents in an older adult or age-integrated apartment building. These buildings are not licensed; however the Enriched Housing Program itself is licensed and regulated by the New York State Department of Health. Most require private payment; however, some may offer private subsidies or accept Supplemental Security Income (SSI) depending on individual eligibility. Some Long Term Care Insurance policies cover a portion of the cost this program.
